Lots of patronage for columnists and talk show hosts

Largest Boycott requires that the specified five major **national media** corporations d (1) GE-NBC, (2) Microsoft MSNBC, (3) Viacom-CBS, (4) Disney-ABC and (5) Time Warner-CNN – launch Columnists, Commentators and Talk Show Hosts TV Channel™.

This channel will give 535 commentators, one 15-minute evening My-Newsmagazine slot every three weeks. (535 divided by the 24, 15-minute slots, 6-12 pm each evening).

The \$1,000-Sentence Mailed by Pastors

The Largest Boycott in History requires that at Boycott-settlement, \$1,000.00 be paid to the first 250,000 degreed pastors – Black and rainbow – who send a fax, or postal-letter, to the chief executive officer of McDonald’s, on the pastor’s letterhead of a physical church, saying (expand as sends sees fit):

“I Support The Largest Boycott in History, against McDonald’s, until the horrific scandal of national media Silence about Genocide Against Black Christians in Sudan has been settled in a nationally televised Boycott-settlement.”

The pastor is to keep the sent-fax or letter-copy record. That any Boycott-settlement will be achieved cannot be guaranteed of course.

The Largest Boycott in History requires that at Boycott-settlement, \$1,000.00 be paid to the first 250,000 degreed, Prod, Cath & Jewish pastors of a physical church or synagogue, Black and rainbow, who send the postal-letter or fax to The Board Members of McDonald’s. TO:
