**OR, EASY # 2:** Get the COUNT-ME-IN EMAILS on the Home Page of [www.gathering-of-eagles.net](http://www.gathering-of-eagles.net) COPY-&-PASTE the email-Text of the 2 emails to MS Word, or, directly-to your COMPOSE for Email # 1 and COMPOSE Email # 2. Type the Subject-Line. Edit spaces, font & line-length as necessary. Save as DRAFT.
